URBAN LOCAL GOVERNMENT
PROCLAMATION NO. 65/2003
OF THE OROMIA NATIONAL
REGIONAL STATE

WHEREAS, it is found necessary to facilitate standardized urban space for development, work and residence as the urban centers in Oromia are numerous and characterized by growing residents;

WHEREAS, it is found important to define the proper organization, power and functions of urban local governments having based upon the provision of Article 103 (1) of the constitution of Oromia National Regional State which stipulates that adequate power for self-rule shall be given to lower bodies.

WHEREAS, it has been found proper to streamline the operation and organization of urban local governments on the basis of good governance and democratic principles so as to enable them create huge development capacity for the development of the Region and improvement of the living standard of residents;

NOW, THEREFORE, in accordance with the provision of Article 49 (3)(a) of the Constitution of the Oromia National Regional State, it is hereby proclaimed as follows:

- 23. Deputy Manager of Municipal Services**

- 1) An urban local government may exercise any of its powers or perform any of its functions and may participate in the financing thereof, jointly or in cooperation, by contract with the Regional Government or with any of their departments or agencies, with:
 - 2) The Regional Government may when it finds it necessary establish regional institution or perform regional activities in the cities.
- 26. Enactment and Enforcement of Laws and Standards**
- 1) The Regional government shall have the authority to issue laws and standards setting the general framework within which cities may exercise powers and functions given to them by law.

- 2) Where the city council dissolves under sub-article (1) of this article, the Regional Executive council shall install a provisional city government and make arrangements to hold fresh elections within a period of six months or within the time defined by the Regional council. The details shall be defined by the Regulations of the Regional Executive council.

CHAPTER SEVEN

*The Relations of Urban Local
Governments with Residents
and Other Bodies*

31. Principle

The relationship between the urban local government and the residents shall be governed by the principle that all local power emanates from the residents. Residents, lone shall recall their representatives in the urban local governments.

32. Participation

- 1) Residents, mass organizations and the private sector shall discuss, debate and express their views on the city annual work programme, budget proposals, project ideas, performance as well as financial and audit reports.
- 2) The urban local government shall organize public forums at least once every three months to enable the residents, mass organizations and the private sector to discuss and debate on issues mentioned in sub-article (1) of this Article. A public meeting may also be called by the city Government where circumstances so require.
- 3) The urban local government shall devise strategy to encourage residents to serve on boards or committees established for the purpose of city business.
- 4) The urban local government has a duty to give prompt response to questions and complaints brought by the residents.

33. The Urban local government and the Urban Kebele

 - 1) The Urban Kebele shall be the administrative sub-unit of the concerned urban local government. The city council shall determine the powers, functions and internal organization of the urban kebele in applying the principle of decentralization.
 - 2) The Urban Kebele shall be accountable to its electorate and to the respective urban local government.
 - 3) The Urban keble shall have a popularly elected council. The composition, manner of election, term and working procedure of the Keble council shall be defined by the city council in accordance with the election law.
 - 4) The Kebele council may make proposals to the urban local government on matters associated with the Kebele.
 - 5) The urban Kebele shall have a social court whose judges shall be appointed by the Kebele council. The details shall be provided by the Law defining the jurisdiction and operations of social courts.
 - 6) Federal and Regional government functions that used to be performed by the urban Kebele prior to the enactment of this proclamation may be performed prior to the enactment of this proclamation may be performed in accordance with the agreement that the Regional Government may make with the Urban local government.

34. Participation of Elderly and Traditional Leaders

Urban local governments shall devise strategy to involve and participate the elderly and traditional leaders for the realization of the development program of the city.

35. Relations with the Police Force

For the safeguarding of the peace and security of the city, the urban local government shall have a police force. With out prejudice to the professional accountability of the city police to the concerned body, it shall be accountable to the mayor. Details shall be defined by directives of the Regional Executive council.

CHAPTER EIGHT**City Finance and Budget Administration****36. Fiscal Year**

The fiscal year of urban local government shall correspond with that of the Regional state.

37. Revenue Sources of the Urban Local Government

- The urban local government may introduce, adjust and collect taxes, rentals and service charges in line with Federal and Regional policies and laws and use the revenue for the development of the city.
- Revenue from urban land and property tax shall be the exclusive income of the concerned urban local government.
- Urban local government may raise funds from own income generating schemes, voluntary contributions and donations.
- The Regional Government may adopt a mechanism of giving subsidies to cities so as to entitle cities a defined portion of the revenue collected within its boundaries. Such government subsidy shall enhance competitive performance among urban local governments and to discourage malpractices. Details shall be defined by law.
- The urban local government shall receive funds from the Regional Government for works it carries out on behalf of the Regional Government.
- With the prior approval of the Regional Government, urban local governments can borrow money from Federal and Regional Governments as well as from accredited financial institutions for capital expenditures in observing the limits of macroeconomic stability set by the Federal Government. Details on the borrowing and repayment procedures shall be defined by regulations of the Regional Executive council,
- Urban local governments may borrow from a city fund or similar institution,

38. Management of Finances

- Every urban local government shall have the power and the responsibility to organize and manage its resources.

- 46. Organization of the Court**
- 1) The City Court shall have two tiers:
 - (a) the court of first instance shall have trial jurisdiction on matters mentioned under Article 47 of this Proclamation.
 - (b) the court of appeal shall have jurisdiction over the decisions of the City First Instance Court. Its decision shall be final.
 - 2) The court shall have a president, judges and staff.
 3. The president and the judges of the city court shall, on the recommendation of the Mayor, be appointed by the city council.
 - 4) One or more judges may sit in every division, of the city court.
- 47. Jurisdiction of the Court**
- The city court shall have exclusive jurisdiction over the following cases:
- 1) Implementation of urban planning laws;
 - 2) Housing and urban land use;
 - 3) City taxes, rentals, service charges and other payments;
 - 4) Environmental sanitation;
 - 5) Municipal services; and
 - 6) Traffic petty offence violations committed in the city.
- 48. Applicable Laws**
- 1) The city court shall apply the Regional Government's substantive and procedural laws concerning the subjects indicated under Article 47 of this Proclamation.
 - 2) Regional laws governing judicial administration shall apply mutatis mutandis, to the city court judges. Judicial administration commission shall be established for the city courts and the judicial Administration Commission shall have the powers and functions given in other laws.

53. Urban Local Governments and the Bureau

The Bureau shall

- 1) Without prejudice to other functions given to the Bureau in other laws, the Bureau shall have the power to lead the affairs of urban local governments in the Regional State,
- 2) The Bureau shall facilitate good working relationship between the Regional Government and the cities in the Region.

54. Additional Functions of the Bureau

The Bureau shall have the following specific functions in relation to urban local governments.

- 1) To examine applications for incorporation and make proposal to the Regional Executive Council;
- 2) To build the capacity of cities through institutional, technical and material assistance;
- 3) To assist cities establish and develop relations with other cities in and outside the country;
- 4) To assist cities to effectively discharge their responsibilities particularly in the implementation of policies, laws and standards;

- 6) To follow up the support that the Regional-Government avails to the cities and devise strategy for its implementation;
- 7) To follow-up and supervise the observance of policies laws and standards of the Regional Government by the cities in the Region, and
- 8) To advise the Regional Government on urban issues as well as conduct or cause the conduct of studies and researches on urban matters.

**CHAPTER FOURTEEN
MISCELLANEOUS PROVISIONS**

55. Experimentation

An urban local government may in getting permission and support of the Bureau experiment on issues associated with its powers and functions. The Bureau shall set the time frame for the implementation and evaluation of the progress of the experiment,

56. Transitory Provisions

- 1) The Regional Executive Council may determine for the implementation of the Proclamation by phase.
- 2) A provisional city administration which shall remain in power till the subsequent election shall be designated by the President of the Region for the urban local governments on which this proclamation applies by phase in accordance with Sub-Article (1) of this Article, The Provisional City Administration shall take over the powers and functions of the city council and Mayor's committee defined by this Proclamation. The Mayor of the Provisional Administration shall have the powers and functions given to the mayor and the speaker of the city council by this Proclamation.

- (b) Shall reorganize the offices of the city administration and reassign, hire and dismiss employees in accordance with the organizational structure it approves;
- (c) Shall have civil service Regulations issued by the Regional Executive Council. The Regulation to be issued shall assist in identifying employees for the placement in the urban local governments.
- 4) The existing urban governance structure shall remain in force until that urban center acquires a city status as per this proclamation.

57. Transfer of Rights and Duties

The rights and duties acquired prior to this proclamation by the city administration shall be transferred to the urban local governments that acquired legal personality in accordance with this Proclamation.

58. Power to Issue Regulations and Directives

- 1) The Regional Executive council may issue Regulations necessary for the proper implementation of this Proclamation.
- 2) The Bureau shall, following the Regulations, issue directives necessary for the proper implementation of the Proclamation and the Regulations.

59. Inapplicable Laws

- 1) Without prejudice to article 56(4) of this proclamation, all Proclamations, Regulations, directives and practices that are inconsistent with this Proclamation shall be inapplicable to the matters contained herein.
- 2) A Proclamation to Establish the Town Administration in the Oromia Regional State, Proclamation No.26/1999, as amended is hereby repealed.

60. Effective Date

This Proclamation shall come into effect as of the day of its approval by the Regional Council, at
